COMP STATED HE WAS LEAVING FOR WORK AND THE LISTED SUSPS EXITED THE LISTED SUSP VEHICLE THAT WAS STOPPED IN THE MIDDLE OF THE STREET IN THE 300 BLK OF W. EIGHT ST. SUSP 1 APPROACHED THE COMP WITH A PISTOL IN HAND AND PLACED IT TO THE COMP HEAD, AND DEMANDED COMP LISTED PROP.
